In the 1997/98 season there were 13 BAGS tracks, of which four are bookmaker-owned. At the time of the MMC's 1989 inquiry, there were eight BAGS tracks operating; of these, four were bookmaker-operated or -owned, a fifth was owned by Brent Walker which acquired LBOs in 1989 and a sixth (Brough Park) was then owned by Ladbroke but leased to an independent track operator.
